RE: Voters' Pamphlet Filing Information for the May 2010 Primary

We hope this information will assist you in filing your optional Voters' Pamphlet statement for the May 2010 Primary Election. Please read the instructions on each form carefully. Please note the two Voters' Pamphlet filing deadlines below.

### Filing Dates:

- **March 9, 2010** - Last day to file for office as a candidate.
- **March 11, 2010** - Last day for Multnomah County and Metro candidates to file Voters' Pamphlet statement.
- **March 22, 2010** - Last day for City of Portland candidates to file Voters' Pamphlet statement. *Portland candidates must wait to file Voters' Pamphlet statement with Multnomah County Elections until after City of Portland certifies candidate list. City certifies by March 18<sup>th</sup>.*
- **May 18, 2010** - Primary Election Day.

- Multnomah County Commissioner #2 - \$300
- Multnomah County Auditor - \$300
- Multnomah County Sheriff - \$300
  
- Metro Council President \* - \$300
- Metro Councilor #1 \* - \$300 (joint with Clackamas Co.)
- Metro Councilor #2 \* - \$100 (joint with Clackamas Co.)
- Metro Councilor #4 - N/A (Washington County only)
- Metro Auditor \* - \$300
  
- City of Portland Auditor \* - \$300
- City of Portland Commissioner #2 \* - \$300
- City of Portland Commissioner #3 \* - \$300

\* Candidates filing for positions that are in more than one county have the option of filing a separate Voters' Pamphlet statement with each county. The fee for each county is based on the number of district registered voters in that county. The fee listed in this packet is for Multnomah County only.
